Auction money plus 18 % GST will have to be deposited on the spot by the successful bidders and stores to be lifted and carry the unserviceable store by the successful bidders at their own expenses and risk within one week after approval of auction proceedings by the Competent Authority, failing which security money will be forfeited without any notice and other auctions may get initiated after obtaining legal advice.

5. Sale tax as applicable in Meghalaya State will be payable by the successful bidder on final bid.

6. Full payment i.e. the residential amount after adjusting the bid security must be deposited by the successful bidder before lifting the goods. The purchaser will be responsible for the stores after auction is over.


7. No transportation and labour will be provided by this HQrs for carrying/lifting of auctioned above stores.
