Entry for Auction bidding will start from 0730 Hrs to 0930 Hrs. Persons who are not authorized to bid will not be allowed.

Each bidder/party has to deposit a sum of Rs. 15,000/- (Rupees fifteen thousand) only along with their bids as bid security/earnest money in cash and register their names with board of officers one hours before the commencement of auction. The money will be refunded later to unsuccessful bidder/parties and bid security of successful bidder will be adjusted in final bid payment.

4. The successful bidder will have to pay 100% bid amount plus admissible Sales Tax/VAT/Surcharge on the spot immediately after finalization of Auction. The purchaser will be responsible for the stores after auction is over.

5. Successful Bidder will lift and carry the unserviceable store at their own expenses and risk within 24 hours after approval of auction proceedings by the Competent Authority. No transportation and labor will be provided by this HQ for carrying/lifting of auctioned above stores.
